POSITION SUMMARY

The Quality Assurance Specialist is tasked with ensuring that all company products meet/exceed our customers expectations. Duties include inspecting incoming raw materials and products to ensure conformity throughout the production process. When products fail to meet our high standards the Quality Assurance Specialist is responsible for dispositioning the product, documenting reasons for the failures and working with the Manufacturing Manager to put in place process improvements to reduce/eliminate recurrence. The Quality Assurance Specialist is also responsible for developing and maintaining our Quality Management System and any/all external quality standard certifications that may be required (ie. ASTM E-84, CAN/ULC S102).

Essential Duties and Responsibilities

The essential functions include, but are not limited to the following:

- Establish and maintain companies Quality Management System, standards and specifications
- Review customer's requirements and ensure they are met
- Work closely with our Purchasing staff to establish requirements from suppliers
- Ensure that our products meet all regulatory requirements, both national and international
- Define quality procedures in collaboration with Manufacturing
- Setup and maintain controls to ensure that proper quality checks are performed
- Own CAPA and SCAR processes
- Monitor performance be gathering relevant data and producing statistical reporting tools
- Work closely with Product Development to define testing requirement to ensure new products meet customer's expectations
- Ensure proper disposition of non-compliant materials, documenting reasons for non-compliance and working in collaboration with the Manufacturing Manager to improve manufacturing processes to reduce/eliminate recurrence
- Ensure Manufacturing direct labor folks are thoroughly trained on proper quality checks
- Execute checks to raw materials and final product to ensure adherence to standards
- Performing all other duties as assigned

Minimum Qualifications (Knowledge, Skills, and Abilities)

- Minimum 5 years Quality Manager experience in high precision, high-tech, and low tolerance machining manufacturing environments
- Experience owning CAPA and SCAR processes
- Skills in numerical and statistical analysis
- Experience developing QMS systems a plus
- Ability to lead people and get results through others
- Excellent interpersonal and communication skills
- Excellent project and program management skills
- Computer proficiency
- Attention to detail
- Ability to work collaboratively with VP Manufacturing, leadership team and employees in improving a system of production control, standard operating procedure, safety, quality control, and performance management
- Ability to adapt and think quickly to handle emergency situations in a start-up, rapid growth environment
- Ability to improve working conditions (safety, quality, service, productivity) and increase employee's skills and capabilities
