- Provide forecast levels for upcoming demand and ordering of raw materials in the right quantities as dictated by the forecast;
- Determine quantities and timing of deliveries with ultimate goal of eliminating production supply shortages;
- Cooperate with cross-company functions to identify other alternatives when stockouts occur;
- Interact with other internal areas to support production needs;
- Receive and process appropriate paperwork against purchase orders to review and identify discrepancies in received inventory;
- Other duties as assigned.
